Service description: My World Workshop provides a safe and secure environment where children can learn through fun using the Montessori Method. It runs once a week on Saturdays

and caters for children aged between 6 - 12 years.

- Procedures for appointing a relevant person for the purposes of the Statement.

SVP and My World Workshop recognise that implementation is an ongoing process and we are committed to the implementation of this Child Safeguarding Statement and the procedures that support our intention to keep children safe from harm.
